- The training could be done either at the industry or at University/institute or in combination of industry and University/institute. In case of combination, student must carry out 01month training in industry and 01month training in University/institute.
  - For B. Tech 2<sup>nd</sup> year students, industrial training/internship can be carried out partially or fully in the summer after 4<sup>th</sup> semester or after 6<sup>th</sup> semester or in combination.
  - For B. Tech 3<sup>rd</sup> year students, industrial training/internship could be carried out fully in the summer after 6<sup>th</sup> semester. In case students have already completed partial (01 month) training after 4<sup>th</sup> semester then that will also be considered during evaluation in 7<sup>th</sup> semester.
