Any dispute or disagreement which cannot be resolved by both parties and any controversy claim or dispute otherwise arising in connection with this contract or breach thereof, shall be referred to the Hon'ble Vice-Chancellor of MMMUT, who will be the sole arbitrator. "DBS" will confirm acceptance of the terms of this Agreement by signing and returning a copy to "MMMUT" within a period of 07 working days.
- During the term of this Contract and for a period of one year thereafter, neither party will hire any 14.6 employee/consultant of the other.
