

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any junior student, including in rowdy or indisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in fresher of a junior student or asking the student (s) to do or perform something which the student will not do in ordinary course and which has the effect of causing or generating sense of shame or embarrassment so as to adversely affect the psyche of a fresher or junior. The case of indulging in ragging is a desire, a sadistic pleasure or showing off power, authority or superiority by seniors over the freshers.

## Induction Programme for New Students (IPNS): 2019-20
