# Notification for 4<sup>th</sup> Round of Spot Counselling of B.Tech-1<sup>st</sup> Year

For filling up the available seats due to non-availability of candidates in respective categories/sub categories and due to the non confirmation of the seat allotted to candidate(s), thereafter upgradation of seats opted by the candidates in the previous rounds of counselling are indicated in the table below.

- Confirmation fee to be deposited on the same day failing which the seat allotment will be cancelled automatically and Rs. 10000/- shall be forfeited.

Important Note: -

- 1. In addition to above, those candidates who have not been allotted seats or withdrawn or not reported in earlier rounds of counselling may appear again in this 4<sup>th</sup> round of counselling.
- 2. The candidates are required to come with **Three Demand Drafts of Rs. 500/-, Rs. 10000/- and Confirmation fee amount** (as prescribed for the Hosteller (girls only) and day scholars) as given below at the end of document.

## Procedure of seat allotment

Admission to the B.Tech.-I Year courses in the University shall be granted based on the merit of the candidates for which the candidate has to appear as per schedule given above. The candidate is required to bring all the testimonials/ certificates/ documents in original & one set of photocopies along with three separate demand drafts of Rs.500/-, Rs.10,000/- and confirmation fee as prescribed below (all drawn in favour of Madan Mohan Malaviya University of Technology, Gorakhpur). Candidates are required to come prepare to stay till late evening as the counselling may get

*extended.* For completing the admission based on his/her merit and choice through counselling, the candidate is required to complete the following steps:

**Step 1 Reporting:** The candidate is required to report at the University in person as per counselling schedule given on university website. He/she must come with his/her Admit Card and submit a non-refundable demand draft of Rs. 500/- towards the counselling fee for each course at the reporting counter.

**Step2 Document Verification**: The candidate must get his/ her Document Verification done on the same day and collect the document verification certificate from the Officer available at the verification counter itself. A demand draft of Rs.10,000/-as part of University fee is essentially required to be deposited at the time of document verification. In case of any deficiency, he/she will not be allowed for further counselling process and the DD of Rs.10,000/-will be refunded.

**Step 3 Seat Allotment:** After all document verification for reported candidates for the day is over then the seat allotment shall be made on the basis of choices submitted by you in Step-1 as per your merit rank on the same day. **The candidates are allowed to change the choices submitted in earlier rounds of counselling.** Since the number of candidates called is quite more than the available seats, hence there is a chance that a candidate is not allotted the seat. University will not be responsible for the inconvenience caused due to this uncertainty.

**Step 4 Confirmation of admission and deposition of remaining fee:** The admission offer needs to be confirmed by the candidate through deposition of the remaining amount of the University fee on the **same day** on which admission offer is made, failing which the seat allotment will be cancelled automatically and Rs. 10,000/- shall be forfeited. Also, such seats falling vacant due to non-confirmation will be allotted to the next claimant candidate in order of merit in subsequent round of counselling.

#### Note:

- 1. Dual merit rank is awarded for the candidates who have claimed for Rural Weightage. Such candidates are called as per the combined merit ranks awarded with rural weightage. If a candidate fails to submit the certificate number 7 at the time of counselling, he/she will be considered for counselling, at the merit rank awarded without rural weightage as per the counselling schedule, which may or may not fall in the range of the ranks called for counselling as detailed above. Such candidates whose combined merit rank without rural weightage falls out of the called range will be out of this counselling process and should watch for subsequent schedule, if any on University website.
- 2. Result of seat allotment will be displayed after completion of document verification process on same day and admission offer letter will be issued on same day. Candidates are advised that they should not leave till the result of seat allotment is not declared and please ensure to collect admission letter in case of seat allotment and withdrawal/continuance of process for subsequent allotment in case of non-allotment.
- 3. Those candidates who has deposited confirmation fee on the day of counselling are required to report in academic section and attend the classes from next day because their attendance counting will begin from the next day.

Note:

- (i) Confirmation fee deposit including hostel fee does not bind the allotment of hostels to the candidates.
- (ii) In case of non-availability of Hostel the hostel Fee component as applicable shall be refunded to the candidate.

### Fee for SC/ST candidates whose guardian's income is less than Rs. 2 Lacs per annum:

As per the prevailing U.P. Govt. orders the candidates belonging to SC/ST category having their parent/guardian income less than **Rs. 2 Lacs per year** and fulfilling other prescribed conditions are eligible for scholarship to the tune of University fees (except certain fees/charges) from Social Welfare Department of U.P. Govt. These scholarships are paid directly to the candidates in their bank account. Interested eligible candidates from SC/ST category have to submit their request on prescribed proforma (available on website) along with following original documents to the Nodal Officer, Scholarship, MMMUT, Gorakhpur for getting their claims recommended for this benefit at the time of depositing confirmation fees.

- Income certificate of parent/guardian having annual income from all sources less than Rs. 2 Lacs
- Original marksheet and Certificate of High School
- Original marksheet of Qualifying examination

Such eligible candidates are allowed to confirm their admission offer by depositing token confirmation fee of **Rs. 27,200/-** for those seeking Hosteller **Rs. 5000/-** for those not seeking Hostel, as applicable subjected to the recommendation of Nodal Officer Scholarship. This confirmation fee shall be adjusted towards their University fees to be remitted by these candidates after getting their scholarship from the Social Welfare Department of U.P. Govt. in the current academic session itself, failing which the University shall take appropriate action to recover the fees and cancelling the admission. Since the scholarship is to be granted by the Social Welfare Department of U.P. Govt. so this University is not responsible for non grant of scholarship to any candidate due to any reason whatsoever it may be.

<u>Note:</u> All candidates who are depositing relaxed confirmation fee as mentioned above have to submit their all relevant documents in original.
