Eligibility to participate and Seat allotment in this round for allotment of vacant Seats:-

The candidates, who have appeared in the Admission Test – 2015 conducted by MMMUT for respective course and have not been allotted seat in previous rounds of counseling are eligible to participate in this round for filling up of the vacant seats in respective category/sub category. Any candidate who does not register in this round of seat allotment will not be considered for allotment of vacant seats.

The University shall make the computerized allotment of seats amongst the claimant candidates who have registered in this round of seat allotment only following the standard procedure which is as detailed below.

- a) **Allotment of sub category seats:** The candidates participating in this round of seat allotment will be allotted only vacant seats based on their merit rank amongst the candidates participating in this round in respective category/sub category. The seats lying vacant in the sub category will be offered to the candidates from respective sub category till the candidates from particular sub category are available.
- b) **Merger of Sub category seats into Main category and allotment of such seats:** The seats lying vacant due to no claimant from the respective sub category shall be merged into respective main category and offered to respective category candidates. Therefore the candidates from OBC/SC & ST are also advised to register themselves for putting forward the claim in case of the seats being available due to merger of sub category into main category.
- c) **Merger of seats of reserve category seats into General Open category and allotment of such seats:** In case of non availability of claimant candidates in the particular reserved category the vacant seat of respective reserve category will be offered to the General Open category, therefore the candidates from the General Open category are also advised to register. University will not consider the candidates who have not registered themselves in this round of counselling.

Schedule for allotment: The date of allotment for reserved sub category/category is **22 July, 2015** and the date of allotment of seats in General Open main category is **25 July, 2015**. Allotment details will be available on University website.

Procedure of Registration and allotment / admission details of vacant Seats (Only Online mode):

1. The interested candidates, who have appeared in the Admission Test – 2015 conducted by MMMUT for respective category/sub category should **essentially register** during **5 PM on 17 July, 2015 to 5 PM on 21 July, 2015** by logging onto university website www.mmmut.ac.in.
2. The registering candidates have to pay Rs. 500/- as non refundable counselling fee for being considered for preparation of merit list to fill aforesaid vacant seats.
3. Please fill in the desired choices of seats on website and submit.
4. After due date the University shall notify the merit list and also the details of seat allotted by **5 PM 22 July, 2015** on its website.
5. The candidates should download the Provisional Admission Offer Letter and report the University at **10 AM on 25 July, 2015** along with the demand draft of applicable fee drawn in the favour of **Madan Mohan Malaviya University of Technology, Gorakhpur**, payable at **Gorakhpur**, failing which the allotment shall stand cancel automatically and seat will be offer to next candidate in order of merit from the notified merit list. 6. The candidates having the Provisional Admission Offer Letter will report in the University in person with following document for the purpose of document verification and validating the candidature. In case of the failure in verification of the candidate the admission offer shall stand cancelled and the seat will be offered to next candidate in the merit list as per merit rank.

1. *Qualifying Examination Certificates and Mark sheets (The eligibility criteria and list of qualifying examinations is given in **Admission Test-2015** information brochure).*

2. *Candidates in respect of whom, the result of the qualifying examination has not been declared by the date of counselling due to any reason whatsoever shall not be eligible for admission.(Please refer to point 16 also).*

- 3.** *Certificate of High school or equivalent examination for verification of date of birth.*
- 4.** *Domicile certificate of Parents (Father or Mother only) of the candidate, issued by the competent authority, for candidates who have passed qualifying examination from states other than U.P.*
- 5.** *Category certificate for OBC candidates issued by the competent authority of U.P. State Govt., if applicable, on prescribed format of U.P. Government as given in the Information Brochure and should be issued after March 31, 2015 (mandatory due to condition of creamy layer of the society).*
- 6.** *Category certificate for SC/ST candidates issued by competent authority, if applicable, on prescribed format of U.P. Govt. as given in Information Brochure.*
- 7.** *Physically handicapped candidates will be required to bring a certificate issued by Chief Medical Officer in prescribed format of U.P. Govt. . A medical board, consisting of general physician, orthopedist, and ophthalmologist may be referred to verify the claim of certificate, if there is any doubt.*
- 8.** *Candidates of Armed Forces category (UPAF) will be required to produce a certificate to this effect issued by competent authority on prescribed format given in Information Brochure.*
- 9.** *Candidates belonging to freedom fighter's category (UPFF) will be required to produce a certificate to this effect issued by competent authority on prescribed format given in Information Brochure.*
- 10.** *The Candidates who have claimed rural weightage will be required to submit a certificate on prescribed format at the time of counseling as given in Information Brochure.*
- 11.** *An undertaking for medical fitness by the candidates & countersigned by his/her father / guardian to this effect that he will submit, a certificate of fitness as prescribed in Information Brochure at the time of joining the University, in case of the certificate is not submitted at the time of document verification.*
- 12.** *In case of offer of admission and confirmation of the seat by the candidate, the candidate is not eligible for any kind of refund of the fees paid to the University. No such claims shall be entertained.*
- 13.** *For the candidates seeking admission in B.Tech.II(Lateral Entry)/MBA/MCA whose result of qualifying examination are not declared by the date of reporting for counselling shall be offered admission subject to the condition that they shall produce the evidence of having passed the qualifying examination securing the minimum passing*

marks as prescribed by the University by 30th August, 2015. Such candidates shall have to submit an undertaking to this effect. In case of non fulfillment of the eligibility conditions by stipulated date, the admission shall be cancelled and no refund of the fee whatsoever the reason may be.

14. Candidates are required to bring the following documents/certificates in original and a set consisting of attested photocopies of the certificates for verification and submission at the time of reporting/document verification.

- (i) Registration Slip
- (ii) Admit Card
- (iii) Mark sheet of qualifying exam.
- (iv) High School Certificate
- (v) Character Certificate
- (vi) Certificate of Medical Fitness/Undertaking of Medical Fitness
- (vii) Following certificates issued by designated authorities as per the format prescribed in the Information Brochure of Admission Test-2015:
 - (a) Domicile certificate, if applicable
 - (b) Category certificate such as OBC/SC/ST, if applicable
 - (c) Sub Category certificate (Freedom fighters/Armed forces/physically handicapped) whichever is applicable).
 - (d) Income certificate (applicable for economically weaker only)
 - (e) GDDA category certificate, if applicable
 - (f) Rural weightage certificate, if applicable

7. Upon reporting by the candidate having Admission Offer Letter, the candidate will be registered in the admitted course after the document verification is over and other requisite formalities shall be got completed on the same day. After completion of all requisite formalities on this day the candidate will be formally admitted in the University and shall have to start attending the classes from the next day without fail.
8. No hostel facility is available for the candidate admitted on these vacant seats; however the hostel facility may be available after few months.
