#### 1.Describe your student life?

#### **CHEMICAL ENGINEERING:**

Water at a gauge pressure of 3.8 atm at street level flows into an office building at a speed of 0.06 m/s through a pipe 5.0 cm in diameter. The pipes taper down to 2.6 cm in diameter by the top floor, 20 m above. Calculate the flow velocity and the gauge pressure in such a pipe on the top floor. Assume no branch pipe and ignore viscosity.

#### **CIVIL ENGINEERING:**

A vertical column 9 m high is fixed at the base and a counter-clockwise moment of 2.1 kNm is applied at the top of the column. A horizontal force P is applied to the column at a height of 4.5 m above the base so as to give a counter-clockwise moment. Determine the value of P so that the horizontal deflections at the top of the column and the point of application of P shall be equal when the deflection are on opposite sides of the vertical line through the foot of the column.

#### **ELECTRICAL ENGINEERING:**

An electrodynamometer wattmeter is used for measurement of power in a single phase circuit. The load voltage is 100 volt and the load current is 9A at a lagging power factor of 0.1. The wattmeter voltage circuit has a resistance of 3 k $\Omega$  and an inductance of 30mH. Estimate the percentage error in the wattmeter reading when the pressure coil is connected

- i) on the supply side
- ii) on the load side
- (Current coil has resistance of 0.1  $\Omega$ .)

#### ELECTRONICS AND COMMUNI-CATION ENGINEERING:

Calculate the capacitance of a circular MOS capacitor of 0.5 mm diameter and having an  $SiO_2$  layer of 80 mm thickness under strong accumulation. Assume the relative dielectric constant of  $SiO_2$ , Er = 4 and  $Eo = 8.854 \times 10$ -14 F/cm. Calculate the breakdown voltage of the capacitor if the dielectric strength of  $SiO_2$  film is 107 V/cm.



# Fiber To The Home (FITH)

Gone are the days when India had fast internet access in only metros and established internet users included only business houses and the elite rich class. After data revolution in the field of mobile data, Indian telecom operators now queue to fight for the fibre internet market. Major telecom operators are all set to provide FTTH service to internet users across the country.




There are two types of FTTH architecture categories namely Active Optical Network (AON) and Passive Optical Network (PON). According to the fibre Optic Association, Active Optical Networks are the easiest way to connect homes with fibre, because fibre connects homes to the ISP. But, although it provides the maximum amount of bandwidth, it tends to be expensive because it requires every home to have a dedicated fibre. On the other hand, Passive

Optical Networks make it possible to share expensive fibre components due to the use of splitters, which divides an input and allows to broadcast services to several homes.

Fibre to the home (FTTH) is a technology that uses optical fibre cable for data transfer directly from central points of the network to terminal usage points like small businesses and homes. It provides superior connection services to high-and-low end users alike and is the paramount service in the FTTx pyramid of providing internet via fibre at different levels. FTTH uses a tree based topology to deliver maximum coverage with minimum bifurcations.

The Optical Line Terminal (OLT) is the main element of the network and it is usually placed in the local exchange. It is the engine that drives FTTH system. Traffic scheduling, buffer control and bandwidth allocation are the most important functions of optical line terminal. The optical splitter splits the power of the signal. That is to say, each fibre link entering the splitter may be split into a given number of fibres leaving the splitter. Usually, three or more levels of fibres correspond to two or more levels of splitters. This enables sharing of each fibre by many users. Opti-

cal Network Terminal (ONT) is deployed at customer's premises. It is connected to the OLT by means of optical fibre and no active elements are present in the link.



The enormously capable fibre optical cable allows FTTH to provide a variety of services alongside high speed internet. Voice over IP (VOIP), multimedia, online gaming, standard and high definition TV along with additional set-top box functions. Voice over IP is an upgrade to standard RJ-11 connector cables and coaxial cables which does not use hardware but an internet connection for calling and provides superior quality, network coverage and a voice quality even better than VOLTE technology.

FTTH provides TV services of advanced nature with amenities including a very large number of channels with high resolution streaming. Television services are weather proof because they

use Internet and not satellite signals to work and this greatly increases their efficiency. It provides separate reserved bandwidth for online gaming and streaming purposes which is an advantage over the old network technologies which had no such possibilities for separate bandwidth or premium services.

FTTH substitutes data connection by copper cables and is the ultimate upgrade to the optical fibre FTTC (Fibre to the Curb). Optical fibre has a great range advantage over copper cables working on xDSL technologies which have a maximum range of 5 km, whereas FTTH has a range of 60 to 100 km. Fully symmetric services (same upload and download bandwidth) are easily achievable with FTTH.

Earlier FTTH was available in India at a high price in only a few selected cities. Now, it is being widely advertised and launched in India by all the major telecom service providers at a very nominal price which promise speeds up to 1 GBPS and premium services like multimedia streaming and 4K TV.

# A Step Ahead

### "We must reform society before we can reform ourselves."

Our country has been carrying an extra weight of primitive rules whose definitions have been questioned lately. These questions definitely point towards the need of a better and concrete law whose validity cannot be suspected.

The country, on September 6, 2018 got its oxygen back as The Supreme court, in four separate but concurring judgements rewrote the history by setting aside its own verdict in the Suresh Kaushal case, decriminalising homosexuality for consenting adults. Section 377 of the Indian Penal Code (IPC) was a 158-year old colonial era provision which criminalised consensual unnatural sex. The judgement proved that societal morality cannot trump constitutional morality and one's bodily autonomy is individualistic. As a matter of fact, this step was the need of the hour since India is a country where culture changes every 100 km.

It is time to bid adieu to prejudicial perceptions deeply ingrained in social mindset and empower LGBTQ community against discrimination. They should be allowed to make their own choices. This community needs the rainbow of hope



for the sake of humanity and must be allowed to live out of the shadows as they too are human beings.

Moreover, the journey of our country towards dignity, equality and liberty didn't take a pause at this verdict. It was realised that the time had come when society had to realise that a woman is equal to her husband in every respect. The dusty Victorian provision of adultery in the Indian Penal Code treated a married woman as her husband's subordinate. Looking into the matter, the apex court made an appreciable judge-

ment which totally scrapped the Section 497 of the Indian Penal Code. Chief Justice, Dipak Misra quoted, "It is time to say husband is not the master". It was one of the most important steps in the direction of women empowerment as it prohibits a man to treat his wife as a property.

The notable thing here is that these two judgements were like two bullets fired from a gun simultaneously (both in the month of September, 2018) which knocked down old and unnecessary customs and practices in our country.

Another historic change which the country has been witnessing as of late is the criminalisation of triple talaq. An ordinance was passed in mid-September this year, to make instant triple talaq a pun-

ishable offence. This practice of oral divorce allowed Muslim men to abandon their wives whenever they wished to. Although people have mixed views on this issue, the ordinance has proved to be a boon for the women of Muslim Community. However, a permanent law is still supposed to be made by the parliament, but this ordinance could still be considered as a wave of hope that washes away an ill-practice being practiced over centuries.

We all know for sure that these changes aren't enough. There are a lot more reforms that need to be made but still these attempts are definiely 'A Step Ahead' towards a better society.

# How To?

## How to generate an Aadhar Virtual ID (VID) and what are its benefits??

Don't want to give your Aadhaar number out? For those of you who don't want to share your unique 12-digit biometric number, you now have an alternative in the form of the Aadhaar Virtual ID (VID). The VID will allow you to authenticate transactions and know your customer (KYC) services instead of providing your Aadhaar number.

# Here's a step-wise guide to generate Aadhaar Virtual ID on UIDAI's resident portal:

- Go to the VID generator on the UIDAI homepage, under the Aadhaar services.
- Enter your Aadhaar number, security code, i.e., the captcha and click on 'send OTP'. You will receive the OTP on your UIDAI registered mobile number.
- Below the field to enter the OTP, you'll have the option to generate a new VID or retrieve the one you have already generated. On submitting, you'll receive the VID on your mobile number.

#### What is VID?

The VID is a temporary, revocable 16-digit random number mapped with the Aadhaar number. The UIDAI, in a statement issued in January, said that one's Aadhaar number cannot be derived from the generated

VID. Currently, VID can be generated on UIDAI's resident portal.

Since this is a digital ID, Aadhaar holders can regenerate it multiple times, which makes it safer than providing your actual Aadhaar number. At present, the VID is valid for a minimum of one day, which means that an Aadhaar holder would be able to re-generate a new VID a day after he has generated the first one. Further, there is no expiry period defined yet for the VID and it will be valid till the time a new one is generated. This facility on the UIDAI website, can only be accessed if you have your mobile number registered in the UIDAI database. This is because all Aadhaar-related online services are one-time password (OTP) enabled and for this, registering your mobile number with UIDAI is a must.
