MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN
MOTILAL NEHRU NATIONAL INSTITUTE OF TECHNOLOGY ALLAHABAD
AND
MADAN MOHAN MALAVIYA UNIVERSITY OF TECHNOLOGY, GORAKHPUR

This MoU is entered into on 25th day of March, 2018 by and between Motilal Nehru National Institute of Technology Allahabad, U.P. (hereinafter called MNNIT) situated at Allahabad (U.P.), an Institute of National Importance established by National Institute of Technology, Act 2007 as amended National Institute of Technology, Science Education and Research Act 2012 of Parliament of Republic of India,

And

Madan Mohan Malaviya University of Technology, Gorakhpur (hereinafter called MMMUT), situated at Gorakhpur (Uttar Pradesh), a University of State Government by Act of U.P. State Government.

The aforesaid organizations are hereinafter referred to individually as *Institute/University* and collectively as *institutions*.

1. Objectives of the MoU

The objectives of the MoU are:

- a) Development of joint education programmes.
- b) Exchange of faculty members and students for short duration.
- c) Joint or collaborative research projects and publications.
- d) Joint organization of technical meetings, international workshops, conferences, seminars, faculty development programs, symposia, etc.
- e) Promoting collaboration in various academic activities.
- f) To encourage bright students of MMMUT to come for higher education and internship at MNNIT.
- g) Helping in increasing the placement of students and consultancy projects.

2. Technical Areas of Collaboration

- a) To implement a Continuing Education Programme to improve quality of teaching and technical staffs of MMMUT through short-term/long-term certificate courses at MNNIT. Faculty members of MNNIT could also be sent to MMMUT for necessary guidance.
- b) To provide academic interaction by delivering Special Lectures at MMMUT on topics of relevance to modern industry, start-up, skill India, digital India, community development, etc.



- c) Organizing joint workshops/conferences and Personality/Professional Development Programmes for enhancement of skills to Faculty, Staff and Students.
- d) To provide necessary support for establishment of Video satellite link and assistance in development of E-class rooms, Lab, Curriculum, establishment of research Labs, Training and Placement and Library etc. at MMMUT.
- e) Usage of academic infrastructure of MNNIT for MMMUT students and faculty members.
- f) To facilitate the training for teachers and postgraduate students.
- g) Guidance for enhancement in infrastructural development of MMMUT.
- h) Joint supervision of M. Tech. and Ph. D. theses as per MNNIT/MMMUT norms.
- i) Joint International and National sponsored/consultancy projects.

A specific plan will be worked out by the institutions depending upon availability of resources.

3. Terms and Conditions

- a) The cost of development of infrastructure at MMMUT shall be borne by MMMUT.
- b) For continuing education to MMMUT teachers and students, the financial arrangements will be made by MMMUT as per norms.
- c) For the visits related to advice and consultancy, travel and other expenses of MNNIT Faculty and Staff shall be reimbursed on mutually agreed terms.
- d) The faculty members and students of MMMUT may use the library facility of MNNIT for short-time free of cost as per norms of Central Library, MNNIT Allahabad.
- e) Usage of MNNIT academic infrastructure can be allowed for limited period subject to its availability, approval of Head of the facility/department as per Institutions norms.
- f) Both institutions agree to help, identify and invite the faculty members and researchers from the other institution to participate in conferences/seminars/symposia, workshops and short-term courses.
- g) This MoU may be amended, renewed and terminated by mutual written agreement of the *institutions* at any time.
- h) Either *Institution* shall have the right to terminate this MoU upon 60 days prior written notice to the other *Institution*.

4. Confidentiality

- a) The MNNIT and the MMMUT agree to hold in confidence all information/data designated by the *institutions* as being confidential which is obtained from either *institute* or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other *institution*.
- b) The above confidential clause under this MoU excludes the information/data possessed by either *institution* before entering into this MoU or independently developed and/or information already available through public domain.

5. Duration of MoU

This MoU, unless extended by mutual written consent of the *institutions*, shall expire in Five years after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended for another two years by mutual consent.

6. Coordinators


Both Institutions will designate persons who will have responsibility for co-ordination and implementation of this agreement.


7. Intellectual Property Rights

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutions.
