


3) Market Potential

The college shall make available their present infrastructure (with some up gradation if required) to form these centers. These centres (created at the College) shall act as EXON® - Online Examinations centres & ASSESS Centers

GOLS is already present in the market and offering its online examination and Assessment solutions to education institutions like Amity University, Bioinformatics Institute of India and corporate (under the brand name of ASSESS) like Cipla, Ranbaxy, Reliance and many more.

5.2) No of Computers:

Testing Center should have minimum of 50 computers installed and ready for use.

5.3) Software Licenses

Testing centers are required to have appropriate software licenses for all Operating systems and application software installed on the workstations used for delivering tests.

Note: - EXON Solutions will install software in the server and the client terminals from time to time as per the requirements. The Software would be Authentic, Original, and screened of viruses & spywares etc. The college management would be informed of software installation in advance.

5.4) Power Supply

Testing centers must provide a reliable power supply to the administrator and testing stations, file server, and printer. In some locations, sudden or frequent power failures or outages may be common. To minimize the risk of damage to testing data and equipment, GurukulOnline Learning Solutions recommends connecting an uninterruptible power supply (UPS) or other power protection device to the administrator workstation or file server where the shared file storage is located. There should be a minimum 3 hours availability of Power back-up.

5.5) Internet Access

The testing centre must have access to the Internet via an ISDN Line or a Lease lines @25kbps/computer. Hence, total required bandwidth = No. of computers*25kbps/computer

5.6) Printer

The testing centre must have an inkjet or laser printer in the local network for printing temporary results after the test. The college could be charged (not more than Rs.50) from the students for the print.

5.7) Test Administration Personnel

The testing centre administration personnel will undergo a training program conducted By GurukulOnline Learning Solutions. The Test Administrator will have to undertake the following activities at the Test Center.

- Check and verify the candidate identity at the time of examination
- Handle Internet connectivity related issues
- Communicate all exam related information not conveyed in Instructions to candidates as and when called for.
- · Continuously monitor candidates during exam for any unethical practices.
- Allow one candidate per workstation during the progress of examination
- Prevent unauthorized access of people during the progress of examination
- Perform all security checks recommended by GOLS for each examination from time to time.
- · Report and document unusual or suspicious activity
- Provide assistance to candidates in printing results
- Collect candidate feedback during the progress and after the conduct of examination
- Interact with GOLS admin personnel via chat or telephone in the event of problems during the conduct of examinations

- Key in details of the candidates appearing for examination/assessment either offline (attendance sheet) or on GOLS website. If done offline the College shall send the same through courier in a sealed envelope.
- · Perform all responsibilities in a courteous and professional manner

5.8) Security Conditions

It is a fact that security is a critical aspect for conducting examinations and it is also known that any laxity in security can lead to defeat of the purpose of examination.

The test centers should follow security conditions like:

- > Firewall protection at center's server to prevent unauthorized access in to the Online Examination system during conduct of examination.
- Allow only one candidate to access one workstation during the progress of examination. No other person should be allowed to sit beside the candidate during the examination.
- > Do not allow copy and/or print question paper other than what is allowed legally.
- Prevent unauthorized access of people during the progress of examination
- > Have Test Administrator to monitor the conduct of examinations. Only the bonafide candidate should be present in the examination hall.
- > Perform all security checks recommended by GOLS for each examination from time to time.

6) Financials:

The testing center on being appointed as an **EXON®** Center would be assigned candidates for various exams & tests conducted by GOLS for reputed institutes and organizations on a regular basis. GOLS will pay College for using the infrastructure as described in the below matrix.

- No of hours taken as the actual duration of the test the candidate is assigned for. For e.g if 30 candidates appear for 3 hrs exams in a group, then the total no of calculated hours is 30*3=90 hrs.
- The above table is given with a view that colleges are rewarded even if business does not
 achieve volume. However, slab calculation will be based solely on the basis of actual volume of
 business generated and the rate applicable will be the rate for that volume of business and NOT

HIGHER. For e.g. if the business generated is 450 hours then rate applicable for the whole of 450 hours is Rs.35/ hr. However, if the volume is say 1350 hours then rate applicable for the entire volume isRs.30 for hour and not for the first slab of 450hrs @Rs.35/hr and the balance @Rs.30 hr. The rate applied will be 1350*30= Rs.40,500. Similarly if the volume is 3601 hours then the payable amount is 3601*15= Rs.54,015.

- Quarter is a period of three calendar months ending in March, June, September, and December
- The College cannot charge more than Rs. 50/- per page directly to the candidates to print their results/certificates. This would be an added source of revenue apart from the above.

7) Terms and Conditions

- The College or the College staff shall not knowingly collaborate with candidates or individuals, to impersonate copy or tamper with the EXON® system or examinations conducted by GOLS for itself or for its customers. In case, the College comes to know of any such irregularity, the same should be intimated to GOLS immediately with all the details. The College should also take immediate necessary steps to prevent occurrence or such events.
- 2. The College shall offer at all times and maintain, Computing facilities, minimum 50 PIV Computers (as mentioned in point 5) and above with built-in web cam. Leased line/dedicated broadband connection from a service provider. The College is also required to provide internet back up arrangement, UPS facility of at least 15 minutes and diesel power back up arrangement to run its computer set up for at least 3 hours (to provide trouble free services in case of power failure for providing uninterrupted services to students.), quality headsets, comfortable seating arrangement, ventilation, and students utilities like drinking water and clean toilet facilities preferably separate facilities for ladies and gents.
- 3. The College shall make available EXON® Center at the time of examination/assessment in running conditions, all the equipments necessary for running the Centre as per the

GOLS specifications including number of computers with accessories such as headsets with mike, web-cam. These examinations would be conducted mainly on Saturdays, Sundays & public holidays. The College will be informed at least 7 days prior of the Examination/assessment schedule date.

- The College shall provide efficient and courteous service to students at all times. The college shall allow/help authorized students with their online examinations.
- The college at all times shall display the board of EXON Center. This board shall be provided by GOLS.
- All the payments will be made to College on quarterly basis and would be subject to all taxes including TDS (Tax Deducted at Source) for which GOLS shall issue certificate wherever applicable.
- 7. The College should also be open to the idea of conducting offline examination. The details shall be worked out on case to case basis.
