Detailed Guideline of University Fee Refund Policy for B. Tech. first year /BBA Ist year /B. Tech. (LE) second Year/B. Pharm Ist Yr. and B. Pharm IInd Yr. (LE)

(As per Guideline issued by AICTE for the Academic Session 2025-26)
If a candidate wants to withdraw his /her candidature after seat allotment and deposition of the acceptance/confirmation fee and (or) remaining fee, then fee will be refunded as per following University Fee Refund policy

S	Fee Refund Policy
No.	
01.	In the event of a student withdrawing before the start of the Course(as per the academic calendar of university), the university shall refund the Fee collected after a deduction of ₹6000/-(₹5000/- towards document verification Fee plus ₹ 1000/- towards processing fee).
02.	In case, if a student leaves after joining the Course and if the vacated seat will consequently fill by another student by the last date of admission(11/08/2025), the university shall refund the Fee collected after a deduction of ₹6000/- (₹5000/- towards document verification Fee plus ₹1000/- towards processing fee) and proportionate deductions of monthly Fee and hostel rent, where applicable.
03.	If a student leaves after the last date of admission i.e.11/08/2025, the university shall ONLY refund the caution money.
04.	The last date for withdrawal of admission for the purpose of refund of fee shall be as per the last date 11/08/2025.

## Process for withdrawal/cancellation of admission and fee refund

The candidate may apply for the cancellation of his/her admission and fee refund request through the candidate login of counselling portal.
Once the cancellation request will be received, it will be processed, and refund amount will be credited as per the bank details (for the refund if any) submitted by the candidate at the time of registration.
Any cancellation request sent through other than counselling portal will not be entertained.
The refund request OR refund due to admission cancellation after third round of counselling shall be processed within six weeks' time. However, refund requests, made after fourth or subsequent rounds, shall be processed after the last date of Admission for the session 2025-26. Such refunds usually take three months' time after the last date of Admission.
Please fill all the bank account related information VERY CAREFULLY for timely refund.
If the refund gets stuck or goes to the wrong account due to the incorrect/ wrong information furnished by the candidate, then the University will not be responsible.
